The Emerging Leaders Program (ELP) is designed for professionals in the crop insurance industry that seek to increase their knowledge and hands-on experience with key issues. Throughout the program, Emerging Leaders receive advocacy and communications training, and have the opportunity to attend three Crop Insurance and Reinsurance Bureau (CIRB) Executive Committee Meetings. The program will help build the next generation of crop insurance leaders.

Eligibility Requirements: The CIRB Emerging Leaders Program is open to all employees of CIRB member companies. To be considered, applicants must be nominated by a member company. The program will take place from August 2024 to April 2025. Applicants who are selected must commit to participating in the full program schedule of events. The schedule of events is located on the next page. In addition, participants will be required to pay a program fee, set each year by the CIRB Executive Committee, and will be responsible for their own travel costs for all events.
