Dear Friends,

Sixty years ago on July 1, 1964, a group of 18 crop insurance companies formed the Crop Insurance Research Bureau. Their mission was to inform the public about the availability of crop insurance through the private insurance industry. Over the years, much has changed. CIRB changed its name to reflect the growing role of the reinsurance industry. Once an organization for mutual insurance companies only, the membership was opened up to include stock held companies, brokers, and others who want to protect, preserve, and improve the program.

A common theme through all of the years is the membership focus on innovation and forward thinking. As a result, CIRB membership has grown, shareholders look to CIRB's collective voice to guide strategy, and a new generation of leadership is being prepared to tackle challenges that lie ahead.

In our nation's Capital, influence is best achieved through coalitions – collective groups, sharing a unified message. That is exactly what the CIRB-led Crop Insurance Coalition has done since its inception in 2012. Now over 100 members strong, the Coalition is a powerful group that has influenced lawmakers in critical policy decisions, from farm bills to the President's budget. In addition to activating quickly during legislative process, the Coalition has worked to share proactive messaging regarding the federal budget and appropriations process, as well as positive messaging around the importance of protecting and preserving crop insurance in the upcoming Farm Bill.

This year, CIRB welcomed the eighth class of Emerging Leaders Program. Already, program participants have had the opportunity to learn about the legislative process and advocate for crop insurance on Capitol Hill. While we are proud of what this program has done, we are even more excited for the future as we continue to find ways to provide meaningful educational experiences and help participants build the foundation that will ultimately allow them to lead the industry in years to come.

When the forefathers of CIRB met to create this organization, do you think they realized what it would become all these years later? Like you, my hope is they would be proud of all that CIRB has accomplished. So, as we celebrate 60 years, let's raise a glass to what has been accomplished, and look toward the future with anticipation, motivation, and confidence that CIRB will continue to adapt to meet the new challenges of the day.



#### POLICY CONFERENCE AND FLY-INS

As a non-election year, CIRB was excited to host not just one fly-in, but two in 2023! The fly-in and policy conference in April kicked off with a fundraiser for Rep. Austin Scott (R-GA-8), who is the Chairman of the House Agriculture Subcommittee on General Farm Commodities and Risk Management.

The following day, fly-in participants had the unique opportunity to have breakfast with House Agriculture Committee member Tracey Mann (R-KS-1), who provided the group with a state of play on the 2023 Farm Bill and talked about the importance of crop insurance to his Kansas communities. Other Speakers included Crop Insurance Coalition members and Food and Ag Climate Alliance (FACA) partners from the National Council of Farmer Cooperatives, American Farm Bureau Federation, and the Environmental Defense Fund. The group rounded out the morning with fan-favorite and Coalition partner Mary Kay Thatcher with Syngenta.

Throughout the event, CIRB met with several members of Congress, including Rep. Dusty Johnson (R-SD), Rep. Michelle Fischbach (R-MN-7), Senator Roger Marshall (R-KS), Rep. Cindy Axne (D-IA-3), and Senator Joni Ernst (R-IA).

During non-election years, CIRB also hosts an October fly-in, where we focused on meeting with new faces in Congress. In particular, we visited with Members of Congress who are not on the Ag Committee, may be new to Congress and the Farm Bill, and have less familiarity with crop insurance. The group also heard from staff members from the House and Senate Agriculture Committee Majority and Minority staff, or the four corners, as part of a farm bill panel. The staff discussed their Members' farm bill priorities and provided an update.

#### **CONGRESSIONAL HEARINGS AND BRIEFINGS**

Meador, the head of Rural Community Insurance Services, talked about the importance of protecting, preserving and improving crop insurance in the 2023 Farm Bill.

#### **ANNUAL MEETING**

# COMMODITY CLASSIC

CIRB staff attended the 2023 Commodity Classic in Orlando, FL, and collected testimonials from farmers about why they support crop insurance.

Commodity Classic is the annual meeting of several Crop Insurance Coalition partners, including the National Corn Growers Association, the American Soybean Association, the National Association of Wheat Growers, the National Sorghum Producers, and the Association of Equipment Manufacturers.

# FACA WORKING GROUP CO-CHAIR

CIRB joined the Food and Agriculture Climate Alliance (FACA) in 2022. FACA was founded to develop climate-related policy recommendations for the upcoming Farm Bill that farm groups, environmental organizations, and others in the agriculture and food value chain could support. CIRB co-chaired the government relations and communications working group on crop insurance, commodities, and credit with the Environmental Defense Fund. Final recommendations included opposition to AGI limits, general support for the crop insurance program, and the need for additional studies on the impact of climate-smart agriculture practices on crop insurance. CIRB has continued as an active member of FACA.

# **CROP INSURANCE COALITION**

The Crop Insurance Coalition was established in advance of the 2012 Farm Bill by CIRB. Today, CIRB provides intel, analysis, and communications support to coalition partners.



#### **DIVERSE MEMBERSHIP**

The Coalition includes more than 100 organizations, including lenders, farm organizations, key voices in the conservation community, agent organizations, and several ag input providers.

#### UNIFIED VOICE

The Coalition collaborates on messaging to ensure a unified voice in efforts to protect and preserve farmers' access to affordable crop insurance across the U.S.

#### EDUCATE & DEFEND

The Coalition works together to educate members of Congress and defend against attacks on the effective public-private partnership that protects our nation's food supply.

#### COALITION ACCOMPLISHMENTS

- Drafted, circulated, and sent a letter to the Administration, and the House and Senate Budget and Appropriations Committees in support of protecting crop insurance during the FY23 budget process. Over 60 Coalition partners signed the letter.
- Shared updated Myth v. Fact documents with Coalition partners for use during the spring fly-in season.
- Developed and shared farm bill messaging tool kits with Coalition partners to use on social media and in member communications.
- Provided Coalition partners with Congressional and Administration updates.


# CIRB POLITICAL ACTION COMMITTEE
